### **OVERVIEW**

The Blue Mule 2-Hose Low Volume Foam-All is a combination applicator for applying one or two chemical products as wet, clinging foam. This venturi injection system uses city water pressure (35 - 125 PSI) to draw and blend chemical concentrates into the water streams to create accurately diluted solutions. Precision metering tips are used to control chemical usage independently for each hose. The mixed solutions flows through the hoses to the "airless" foam wands which draw in atmospheric air to create and project foam in a fan pattern or narrow stream. Hoses can be used independently or simultaneously.

## **SAFETY & OPERATIONAL PRECAUTIONS**

- When connecting to a potable water supply follow all local codes for backflow prevention.
- For proper performance do NOT modify, substitute nozzle, hose diameter or length.
- Manufacturer assumes no liability for the use or misuse of this unit.
- Wear protective clothing, gloves and eye wear when working with chemicals.
- Always direct the discharge away from people and electrical devices.
- Follow the chemical manufacturer's safe handling instructions.
- NEVER mix chemicals without first consulting chemical manufacturer.

## TO INSTALL (REFER TO DIAGRAM ON NEXT PAGE)

If you are connecting to a potable water supply follow all local codes for backflow prevention.

- 1. Mount the unit to a suitable surface above the chemical supply to prevent siphoning.
- 2. Connect hose(s) as shown in the diagram.
- 3. Flush any new plumbing of debris before connecting water.
- 4. Connect water supply. Install a water filter if water piping is older or has known contaminants.

# Set the chemical dilution ratio by threading one of the color coded metering tips into each chemical check valve. See chemical labels for dilution ratio recommendation or consult your chemical supplier.

- For the strongest dilution ratio do NOT install a colored metering tip.
- The dilution ratios in the metering tip chart are based on water thin chemicals with a viscosity of 1CPS.
- Thicker chemicals will require a larger tip than the ratios shown in the chart.
- Application results will ultimately determine final tip color.
- Select the tip color that is closest to your desired chemical strength and thread it into the tip holder. DO NOT OVER-TIGHTEN.
- Push the chemical tube over the check valve barb and place the suction tube in the chemical concentrate.
- If necessary, cut suction tube(s) to length before attaching suction strainer.

#### **TO OPERATE**

- 1. With foam wand in hand open the inlet ball valve to begin application.
- 2. To switch to a wide or narrow pattern turn the Bullet nozzle in clockwise 1/4 turns.
- 3. Make final metering tip adjustments based on application results.
- 4. When foaming is completed, close the inlet ball valve.
- 5. Rinse before foam dries.



#### FORMULA

#### GPM × 128 ÷ Desired Dilution Ratio = oz/min

- See Unit Flow Rates chart for GPM
- Use 20 for 20:1 dilution ratio, 30 for 30:1, etc.
   Match adjaulated europes per minute (az/min)
- Match calculated ounces per minute (oz/min) to nearest oz/min in Metering Tip Selection chart.

<ul> <li>Inlet ball valve not completely open <ul> <li>Completely open the inlet ball valve.</li> </ul> </li> <li>Not enough chemical - metering tip too small <ul> <li>Install larger metering tip.</li> </ul> </li> <li>No metering tip installed or metering tip too large <ul> <li>Install smaller metering tip.</li> </ul> </li> <li>Improper chemical <ul> <li>Ensure product is recommended for foaming and the application.</li> </ul> </li> <li>Chemical tube not immersed in chemical or chemical depleted <ul> <li>Immerse tube or replenish.</li> </ul> </li> <li>Discharge hose too long or wrong size or kinked <ul> <li>Straighten the hose or replace hose with correct size.</li> </ul> </li> <li>Water pressure or water volume too low/inlet piping too small causing poor chemical pick up <ul> <li>Increase water pressure or water volume</li> </ul> </li> <li>Soil has hardened on surface; always rinse before chemical dries <ul> <li>Reapplication may be necessary.</li> </ul> </li> </ul>	<ul> <li>9. Chemical tube stretched out or pin hole/cut in chemical tube <ul> <li>Cut off end of tube or replace tube.</li> </ul> </li> <li>12. Vacuum leak in chemical pick-up connections <ul> <li>Tighten the connection.</li> </ul> </li> <li>13. Water strainer clogged or missing/injector inlet orifice clogged <ul> <li>Clean or replace strainer; check/clean inlet orifice for obstructions. DO NOT DRILL OUT.</li> </ul> </li> <li>14. Hard water scale or chemical build-up may have formed in the injector body causing poor or no chemical pick-up <ul> <li>Follow Preventive Maintenance instructions below, using hot water and/or de-scaling acid. When there is no draw at all, carefully remove fittings and soak entire injector body in de-scaling acid.</li> </ul> </li> <li>15. Foam wand clogged or scaled up / wrong nozzle <ul> <li>Hard water scale or chemical build-up may have formed, soak entire foam wand in de-scaling acid / see requirements.</li> </ul></li></ul>			
	<ul> <li>16. More than one chemical ball valve open or no chemical valve open         <ul> <li>2 &amp; 3 Way models only</li> </ul> </li> </ul>			

PREVENTIVE MAINTENANCE: When the unit will be out of service for extended periods, place chemical tube(s) in water and flush the chemical out of the unit to help prevent chemical from drying out and causing build-up. Periodically check and clean chemical strainer and replace if missing.
